1. Policy Statement

At Finton House, we are committed to giving all pupils the opportunity to achieve personally, socially, physically and academically. We do this by taking into account the varied experiences and needs of pupils. We value all pupils as individuals and offer a broad and balanced curriculum that gives each child the opportunity to achieve their potential. Finton House School promotes the individuality of all children, irrespective of ethnicity, religion, attainment, age, disability, gender or background.

Aims

We aim to ensure that all children, irrespective of ethnicity, culture, religion, home language, family background, learning difficulties, disabilities, gender or ability, have the opportunity to experience a challenging and enjoyable programme of learning and development.

Admissions

Finton House's aim is to encourage applications from candidates with as diverse a range of backgrounds as possible. This enriches our community and is vital in preparing our pupils for today's world. Finton House is committed to equal treatment for all, regardless of a candidate's sex, race, religion, disability, gender reassignment and sexual orientation. (See Admissions Policy)

Access

In addition to admission, pupils with protected characteristics (race, disability, sexual orientation, religion or belief (or lack thereof), gender assignment, sexual orientation, or pregnancy or maternity) will not be discriminated against in relation to access to the school's benefits, curriculum, facilities or services. Academic Ethos and Curriculum

Each child is valued as an individual and encouraged to work to their highest level of achievement. Encouragement is given verbally and in written form and through formal rewards. The broad and balanced curriculum supports access to a range of subject and all pupils access the curriculum with equal opportunity. (See Curriculum Policy and Pastoral Care Policy)

Special Educational Needs and Disabilities (SEND)

Finton House School will strive to make appropriate provision for students with SEND. Initial and on-going pupil assessment is intended to enable pupil differences to be identified and supported. The School aims to offer places to children with a broad range of needs, but this is dependent upon the School being able to meet and continue to meet the child's needs. Disability and access for people with disabilities

The School has an ongoing duty to make reasonable adjustments for pupils with a disability to ensure they do not suffer a disadvantage in comparison with other pupils. (See Accessibility and disability plan, Special Educational Needs and Disability Policy)

Religious Observance

The School is religiously inclusive and welcomes and respects the rights and freedoms of individuals from all religions and faiths (or with no religion or faith) subject to considerations of safety and welfare and the rights and freedoms of other members of the School community.

The school provide assemblies which bring together the whole community to reflect on moral, spiritual and ethical issues. It is fully understood and respected that pupils may be required to be absent on occasion during the course of the school year in order to observe religious holidays.

The school promotes the 'British Values': democracy, the rule of law, individual liberty and mutual respect and tolerance of those with different faiths and beliefs.

Bursaries

Families of children aged seven or over are able to apply for a means tested bursary award, should places be available. Arrangements for the award of scholarships, bursaries and prizes are made with the intention of facilitating increased access for candidates. Dietary Requirements

The School employs an outside catering company who provide a nutritious and balanced diet with plenty of choice at meal times. Provision is made at all meals for pupils who have special dietary requirements based on preference, religion, SEND needs or medical advice. Pupil council and Parent Rep Meetings discuss the school's food provision and influence future menu choice. (See the
